filings, with the Registrar of Companies, Mumbai ("Registrar of Companies" or "ROC"), valuation report if applicable, general meeting notices with explanatory statements, auditor's report; (iii) statutory registers and BENPOS statements; and (iv) annual returns filed with the ROC in every financial year since the inception of the Company. [Pursuant to the review of documents, as specified above, we hereby confirm as under :

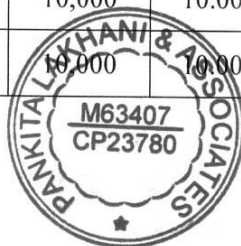

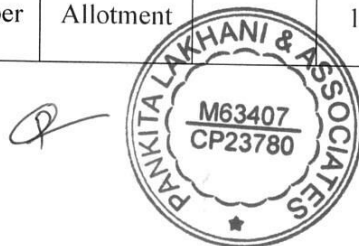
