Observations:

The Company experienced delays in filing certain forms with the ROC, and appropriate additional fees have been paid where applicable. In 2008-2009, a charge of ₹1,05,00,000 in favour of M/s Ambernath Jai-hind Co-Op. Bank Limited, created on 20.03.2009, was required to be filed by 19.04.2009 under Section 125 of the Companies Act, 1956. However, the filing occurred on 31.08.2009, resulting in a delay from 20.04.2009 to 31.08.2009. A condonation of delay order was issued by the Company Law Board, Mumbai Bench, in 2009, acknowledging that the delay was due to inadvertence. Furthermore, the AGM date for the financial year 2011-12 is recorded as 12th August 2011 in Form 23B but as 30th September 2011 in Form 23AC. A similar discrepancy is observed for the financial year 2012-13, where the AGM date in Form 23B is mentioned as 5th July 2012, while in Form 23AC, it is recorded as 29th September 2012.

Additionally, the company has inadvertently used the wrong letterhead in several documents filed with the ROC. It is also noted that the company has not filed Form 23B from its inception until the year 2010.

Conclusion:

Based on the records examined, it is hereby confirmed that the Company has taken corrective actions, where necessary, to address the delays, errors, or non-compliance in ROC filings. Further, the Company is advised to ensure timely and accurate filings in the future to avoid penalties or non-compliance under the Companies Act, 2013.


